- 1) The plaintiff, in relation to his activism and fight against rape culture in Steubenville, Ohio, has begun his 24 month prison sentence, and is currently in Federal custody at Petersburg-Low Federal Correctional Complex in Petersburg Virginia, and no longer has access to ECF or the above e-mail address.
